INTRODUCTION



Sylvan Lake is a growing community in an enviable natural setting in central Alberta. Our community is committed to shape its future as a place where all residents enjoy a healthy quality of life. This is what our first Community Social Master Plan is all about: creating a community that offers a healthy quality of life for all.

What does a healthy quality of life "look like" for residents of Sylvan Lake? We explored this question as part of our 2015 Social Needs Assessment.



Eight components of quality of life emerged as being of greatest importance to our community. These are:

- Households are able to meet their basic needs. These include shelter, food, clothing and transportation.
- Residents have supports and services to meet their mental health needs.
- Residents have supports and services to maintain a healthy lifestyle and meet their physical health needs.
- Residents are engaged positively in the community.
- Residents have strong, healthy relationships.
- Residents feel safe in their homes and in the community.
- Residents have a sense of purpose, through their contributions to family, the community, work and/or learning.
- Residents are able to enjoy the lake and the natural surroundings.

The relative importance of each of these components to individual residents will vary depending on their personal values and circumstances.


This plan identifies what our community is setting out to do over the next three years to address the quality of life priorities identified in our 2015 Social Needs Assessment.¹

INTRODUCTION

This Community Social Master Plan has been developed by residents and individuals who deliver a range of services in our community. These individuals contributed their experience and ideas as members of four sub-committees focusing on priorities in the areas of housing, income and employment, health and wellness, transportation, and community safety and engagement. The actions identified by the sub-committees and included in this plan range from specific tasks that can be completed quickly, to broader strategies that will require a longer period of time to implement. Although the actions vary in scope and complexity, all will contribute to enhanced quality of life for residents of our community.

This plan was shared with the community at an open house. There is clearly strong community support for action on this plan. (See Appendix D, page D-1.)

While support for the development of this plan has been provided by the municipality, it has been created – and will be implemented – by the whole community. The Town of Sylvan Lake will be but one of many partners having a role in its implementation.



OUR VISION & GUIDING PRINCIPLES



We have a vision for quality of life in our community. This is:

Sylvan Lake is a safe and caring community where residents enjoy a healthy quality of life.

We are confident that this plan will move us toward this vision over the next three years.

GUIDING PRINCIPLES

As this plan was being developed, some key principles emerged. These principles underpin this plan and will guide our approach and decision-making through its implementation.

COLLABORATION

Working together and sharing information, ideas and resources will make us more innovative, more successful in achieving our goals, and more efficient in the use of our resources.

INCLUSION

We welcome people of all ages, cultures, incomes, and abilities to live in our community and neighbourhoods. We want all residents to have a sense of belonging in our community.

SHAPE OUR OWN FUTURE

Sylvan Lake is growing and maturing as a community. We are intentional about shaping our community and the quality of life our residents enjoy. We share our aspirations and plans with the Government of Alberta and our neighbouring municipalities, and endeavour to gain their support in helping us achieve our vision and goals.

PREVENTION AND RESPONSIVENESS

We anticipate and plan how we will respond to social needs in our community. We monitor our community's changing circumstances and needs and take action at the earliest opportunity to prevent social needs becoming larger issues. We provide quality programs and services that enhance the quality of life of residents and are valued by the community.

RESILIENCE

We help residents build their resiliency so they can adapt if confronted with unplanned or difficult circumstances, such as relationship breakdowns, illness, or job loss.



OUR LONGER-TERM GOALS

This Community Social Master Plan focuses on six longer-term goals that define the future we aspire to in areas central to quality of life: housing, income and employment; health and wellness; transportation; and community safety and engagement. We will move toward these goals over the next three years through our collaborative efforts on the actions identified in the following section.

HOUSING, INCOME AND EMPLOYMENT

Our Long-Term Housing Goal: Sylvan Lake has a well-balanced housing continuum

A well-balanced housing continuum exists when housing is available for residents across income levels and household sizes. There is currently an inadequate supply of housing in our community for households with temporary or persistent low income and for those requiring emergency shelter.

We want to accomplish the following in the next three years to move us toward our housing goal:

- Have integrated planning among organizations with mandates for housing and social development in our community
- Have housing and support available in our community for individuals and families experiencing short-term homelessness
- Have an increased supply of low-income and subsidized housing in our community

The actions we plan to take to address the pressing housing needs in our community are:

Our Long-Term Health and Wellness Goal: Sylvan Lake is a community with supports and services that promote good health and wellbeing for residents

Having the best possible physical and mental health is important for our residents to be able to meet their full potential. We are striving to be a community where residents can access services and supports that promote both physical and mental wellbeing. Over the next three years, we want to accomplish the following:

- Have an ambulatory/urgent care clinic opened in our community
- Increased availability of free or low-cost recreational activities
- Residents have increased awareness of healthy food choices
- Residents have improved access to local mental health supports and services
- Residents have improved access to local addiction supports and services

The actions we are going to pursue to move us toward our health and wellness goal are outlined below.

TRANSPORTATION

Our Transportation Goal: Sylvan Lake is a community with a range of transportation options for residents and visitors

Reliable, affordable transportation is needed for residents to be able to get to stores, work, school, medical appointments, and to participate in community activities. Some of our residents, including some seniors and individuals with limited mobility and residents with modest incomes, can find it challenging to be able to afford transportation that allows them to have a healthy quality of life.

The community bus is used by a number of organizations. Its purpose is to facilitate attendance at recreation and cultural programs, activities or events. It is a valued resource that needs to be replaced.

We are seeking to accomplish the following over the next three years to increase access to affordable transportation in our community:

- Low-income seniors and residents with limited mobility have access to subsidized transportation services
- Have a public transportation system in place that includes stops in Sylvan Lake and Red Deer that is affordable for individuals and families with low income
- Community organizations are able to offer affordable group trips using the community bus as part of their programming

The actions we will pursue to enhance transportation services for Sylvan Lake residents are identified below.

Our Safety Goal: Residents feel safe in their homes and in the community

Safety is a concern in all communities. Residents want to feel safe both in their homes and when they are out in the community. They also want comfort in knowing their family members are safe.

To increase the sense of safety in our community, we are going to focus on accomplishing the following:

- Residents and community organizations have a common understanding of bullying, harassment and family violence and know how to respond
- Reduce incidence of petty crime
- Strengthen our community response to family violence and establish a women's emergency shelter in Sylvan Lake

- Residents being more actively engaged in the community through volunteer opportunities

MONITORING AND EVALUATING THE SUCCESS OF THIS PLAN

The Town of Sylvan Lake will be intentional about monitoring and reporting on our progress in implementing this plan and evaluating the success of this plan in moving us toward our vision and goals. As we proceed with implementing this plan over the next three years, we will regularly ask ourselves "are we doing what we said we would do?" and "are we accomplishing what we want to accomplish?" Answers to these questions will help us decide if we need to adjust this plan to respond to changing needs in our community or lever new learnings that would allow us to be more effective or efficient in achieving our goals.

Information about the status of the implementation of this plan will be provided to Town Council on a regular basis by the Town of Sylvan Lake FCSS. In addition, the Town will report annually to the community on our progress in implementing this plan. A formal evaluation will be conducted in 2019 and the evaluation findings will be used as part of our next Social Needs Assessment and to update this plan.

Potential indicators that we could use to monitor and evaluate this plan are presented in the table that follows on page 17. These will be refined as we build experience and capacity within our community for gathering and working with specific sets of indicator data.

The overarching indicator of the success of this plan will be the perception of service providers and residents of quality of life in Sylvan Lake.

The data for this indicator could be obtained by adding some specific quality of life questions to the Town's Annual Satisfaction Survey and from a quick online survey of service providers in the community.²

APPENDIX B: GLOSSARY

Affordable Housing – Rental housing provided at 10% below-market rent.

Ambulatory/Urgent Care Clinic – A clinic, under one roof, that provides medical treatment of non-life threatening injuries. This clinic would be open 7 days a week from 7:00 am – 10:00 pm and have access to laboratory (Lab) and diagnostic imaging (DI) services. It would be staffed by doctors and nurses. It would provide additional supports for mental health and seniors.

Community Engagement – The extent to which individuals feel connected and are committed to the betterment of their community.

Community organizations – Organizations that offer programs or services to residents of Sylvan Lake.

Evaluation – A systematic process to assess the relevance, effectiveness, efficiency and impacts of plans, programs and services to guide future decision making.

Goal – An aspirational statement of what the community is seeking to achieve in the long term.

Indicators – The information that provides evidence related to the implementation of this plan and whether progress is being made towards goals.

Monitoring – Regular, systematic collection of data that provides stakeholders with information about the progress of planned activities and towards goals.

Partner – Individuals or groups that collaborate to plan and implement activities.

Planned accomplishments – Intended changes that can be measured that will result from implementation of planned activities over the next three years. These are the outcomes the community is seeking to achieve.

Quality of life – The general wellbeing of residents of a community or society.

Rent-geared-to-income housing – Rental housing at below-market rent tied to income for low-income households (based on core need - spending more than 30% of household income on shelter costs).

Stakeholder – An individual or group with an interest in a particular issue or the ability to create change.

Subsidized housing – Rent supplements for low-income households living in private market housing.

Utilization-focused monitoring and evaluation – An action-oriented approach to monitoring and evaluation that emphasises the use of findings and recommendations for ongoing improvement.



Collaboration will be key to the successful implementation of this plan

- Shelter is key difficult to leave own home where network is again, housing 1st and have supports at the shelter
- Police force needs to be active and present in the community not just in an enforcement role
- Addressing drug and alcohol related issues would hopefully make the Town safer and reduce some of the crime and unsafe behaviours
