
# Sylvan Lake Social Master Plan 2016 - 2019 progress report







#### **EXECUTIVE SUMMARY**

Developing a community where all people can thrive, requires a coordinated effort from residents, service providers, and government. In 2016, our first Social Master Plan was about creating a community where residents have a healthy quality of life. Individuals contributed their experience and ideas as members of four sub-committees focusing on priorities in the areas of housing, income and employment, health and wellness, transportation, and community safety and engagement. The actions identified by the sub-committees, and included in the Social Master Plan, range from specific tasks that can be completed quickly, to broader strategies that will require a longer period of time to implement. Although the actions vary in scope and complexity, all contribute to an enhanced quality of life for residents of our community.

Eight components of quality of life emerged as the greatest importance to Sylvan Lake. These components are:

- Households are able to meet their basic needs. These include shelter, food, clothing and transportation;
- Residents have supports and services to meet their mental health needs;
- Residents have supports and services to maintain a healthy lifestyle and meet their physical health needs.
- Residents are engaged positively in the community.
- Residents have strong, healthy relationships;
- Residents feel safe in their homes and in the community.
- Residents have a sense of purpose, through their contributions to family, the community, work and/or learning;
- Residents are able to enjoy the lake and the natural surroundings.

As this plan was developed, key principles emerged; collaboration, inclusion, resilience, prevention, responsiveness, and shaping our own future. These principles form the basis of many of the actions contained within the plan.

The 2016 - 2019 Social Master Plan Progress Report - Report Card, identifies action items that are complete and ongoing, and also identifies oustanding goals, that require more work.

Over the past three years, stakeholders have worked diligently to tackle the action items included in the plan. Important to note, is that different organizations, committees, individuals, agencies, have played a role in the accomplishments that have occurred to date.

Key highlights accomplished to date include:

Subsidized Taxi program implemented;

- Creation of the Sylvan Lake Community Housing Committee;
- Sylvan Lake Sustainable Housing Initiative Study completed;
- 'Stress Busters' program implemented in HJ Cody School
- Arts group established though Culture and Tourism Coordinator;
- Community Garden Committee built community garden planter boxes at the Library and Food Bank;
- 40 Developmental Assets incorporated into all Family and Community Support Services (FCSS), and Parent Link programming;
- · Block Parties promoted within the community
- Community Resource Directory updated annually in a variety of formats;
- Community Social Needs discussed at Interagency meetings;
- Community Bus purchase, "CARE-a-Van," completed;
- FCSS Certified Community Support Worker established as Sylvan Lake Housing Support contact through Red Deer Housing Authority and Sylvan Community Housing Society;
- Edible shrubs and trees planted through the Parks Department.

We've completed a lot of our goals; however, we still have work to do. Ongoing, or "still to do" actions include:

- Keep a public transportation system in mind for consideration when community's population approaches 25,000;
- Collect statistics that support Social Master Plan initiatives;
- Sylvan Lake Housing Committee and Town of Sylvan Lake to develop a strategic plan for housing and work with local partners/provincial/federal governments to address low income, affordable, shelters, and transitional housing;
- Implement community bus fundraising plan;
- Community Development Coordinator to work with RCMP and Protective Services in the coordination of public education sessions and discussions surrounding risk factors and strategy development for the prevention of petty crime;
- Expand support and public awareness of family violence, bullying, and healthy relationships through collaborative partnerships with Centre for Positive Relationships and helping agencies;
- Strengthen services and resources to welcome newcomers to Sylvan Lake through coordination of agencies creating new comers packages.
